RENTAL AGREEMENT

1. The renter must be 25 years or older; and driving for a minimum of 5 years or more.
2. The rental amount and security deposit of \$2,500.00 - \$5,000.00 is payable in advance and is refundable if there is no damage or loss and/or no violation of the rental agreement
3. Insurance: The Vehicle is insured to cover Third (3rd) party risk only. The renter is liable for any damage or loss occurred during the rental of the vehicle.
4. By entering into the rental agreement, the renter confirms that he has noted the condition of the vehicle rented to him/her.
5. The vehicle is supplied with spare tire, jack and wheel spanner and the renter is liable for the loss of any of these items.
6. Only the renter who holds a valid driver's license and is insurable under a rental agreement is permitted to drive the vehicle. Any other person found driving will cause a breach of your contract and the entire deposit may be forfeited and vehicle taken away.
7. **Fuel charges if not returned Full will be applied as follows: empty tank \$300.00 ½ tank \$180.00 and ¾ tank \$120.00.**
8. A day is reckoned as 24 hours from the time the vehicle is rented: if you rent the vehicle outside of hours that person is still expected to return before the end of the business day.
9. **A late fee of \$25.00 for the first 5 minutes – 1 hour, 1 hour – 3 hours \$50.00 and a day's rental for any time after that.**
10. The rental is payable in advance.
11. **The vehicle MUST be returned clean. The following additional rates will be charged to the renter if the vehicle is returned dirty: \$30.00, \$40.00 or \$60.00 depending on how dirty the vehicle is upon inspection.**
12. G.I. Rental reserves the right to have the vehicle inspected and checked at any reasonable time by its employee without notice to the renter.
13. G.I. Rental reserves the right to repudiate the agreement at any time without notice, if in the opinion of the owners of any authorized personnel of the Company, if: the vehicle is misused, abused, or used for an illegal purpose or otherwise.
14. It is an offence to disconnect or tamper with an instrument on the vehicle. In so doing the renter forfeits the security deposit.
15. G.I Rentals does not assume any responsibility for the loss by theft or otherwise of articles or personal effects left in the rental vehicle.
16. If an accident occurs the renter is liable up to a maximum of the excess for insurance of the vehicle and any other charges that may occur, plus the loss of use.
17. The renter is responsible to get to our office at his/her own expense, however if it is convenient, we may offer free pick up and drop off and delivery services
